a Maryland corporation, having its principal office at 4509 Beechwood Road, College Park,
Maryland 20740 (hereinafter referred to as the "Corporation"), hereby certifies to the State
Department of Assessments and Taxation of Maryland (the "Department") that:

FIRST: The Charter of the Corporation is hereby amended by striking in its entirety Article
THIRD and substituting in lieu thereof the following:

"THIRD: The name by which the Corporation will hereafter
be known is THE C. S. LEWIS INSTITUTE, INC."

SECOND: By written informal action, unanimously taken by the Board of Directors of the
Corporation, pursuant to and in accordance with Section 2-408(c) of the Corporations and
Associations Article of the Annotated Code of Maryland, the Board of Directors of the Corporation
duly advised the foregoing amendments and by written informal action unanimously taken by the
members of the Corporation in accordance with Section 2-505 of the Corporations and
Associations Article of the Annotated Code of Maryland, the members of the Corporation duly
approved said amendments.

THEOLOGICAL STUDIES, INC. has caused these presents to be signed in its name and on its
